

APPLICATION FOR PERMIT TO TRANSPORT (PTT)

(for those who want to liaison their PTT only)

1. For PTT applications (except for AFP Units/PNP Units/Gov't Law Enforcement Agencies [LEAs]), the FEO Registered Gun Club President/Licensee/Director/Manager of Private Security Service Provider (PSSP) should email the following to csq.gunclub36@gmail.com then contact 0921-6462550 / 0915-2611774 or (02) 723-0401 local 4220 for confirmation: (No Pre-registration, No PTT).

Documentary requirements:

- a. Letter Request and Endorsement.
 - For FEO Registered Gun Club: Letter Request and Endorsement (with Gun Club letterhead) from the Gun Club President to FEO for PTT and Order of Payment (OP) of PTT to include the list of team member/s and firearms details who will participate as official representative of the Gun Club to the Battle of the Gun Clubs 2016.
 - For Private Security Service Providers (PSAs/PDAs/CGFs): Letter Request and Endorsement (with letterhead) from the Licensee/President/Vice President/Corporate Treasurer/Corporate Secretary to FEO for PTT and Order of Payment (OP) of PTT to include the list of team member/s and firearms details who will participate as official representative of the (PSAs/PDAs/CGFs) to the 4th PSA Challenge (2016).
- b. Firearm License or License To Operate (for PSSPs).
 - For FEO Registered Gun Club: Copies of firearm licenses or LTOPF and Firearm Registration for FEO of official participants representing the Gun Clubs.
 - For Private Security Service Providers (PSAs/PDAs/CGFs): Authenticated License to Operate (LTO) (Valid).
- c. Bank Receipt/Deposit Slip for the payment of PTT fee of Four Hundred Pesos (P400.00) per firearm for the duration of the Battle of the Gun Clubs 2016 and 4th PSA Challenge (2016) from residence to Armscor Firing Ranges. The fee can be deposited to the bank account below:

Note:

- 1) The CSG Liaison will bring the PTT applications with supporting documents to EEMD-FEO to secure the Order of Payment and will pay the necessary fees to the Land Bank on behalf of the applicants, then submit the SBR to EEMD-FEO for the processing of the PTTs. CSG Liaison will then send the PTTs to the Gun Clubs and or Private Security Service Providers (PSAs/PDAs/CGFs) thru any fastest available means possible. **Applications for PTTs should be submitted two (2) weeks before this shooting competition.** (No Pre-registration, No PTT).
 - 2) Regional Director (RD), Police Regional Office (PRO) of the PNP is authorized to approve the PTT for this event only, per Memorandum from PNP Directorate for Operation. Thus, you may also submit your application for PTT to PRO for approval of the RD that has jurisdiction to your place of origin.
2. However, only for PSSP such as Private Security Agency (PSA), Private Detective Agency (PDA), Company Guard Force (CGF) especially those based outside NCR, may opt not to bring their firearms/ammunitions and just avail of the house guns (courtesy of the sponsor) especially dedicated in every stages of the 4th PSA Challenge (2016) and may just purchase ammunitions at the venue for this event. Thus, if availing of the house guns then this application for PTT may no longer be necessary.
